For the year commencing 1 April 2026, Northpower Limited will provide a discount for the benefit of Northpower consumers totalling an estimated \$17.8m. This will be a discount of Northpower's distribution charges and the amount which each consumer receives for each eligible ICP will be determined by the usage between 1 April 2026 and 31 March 2027 based on information supplied to Northpower by the electricity retailers. The amount will be calculated using the discount rates in our full pricing schedule available on our website.

This discount will be capped to an indicative maximum payment of \$289.20 (plus GST) per eligible ICP. The final capped amount will be calculated based on the actual usage for the FY27 period of each eligible ICP at the time of payment. The discount payment will be applied as a credit on the electricity bill from the ICP's current electricity retailer during May or June 2027.

To qualify as an eligible ICP, an ICP must be supplied from the Northpower electricity network with a registry status of "Active" (Connected) on 1 May 2027, and be a current customer of an electricity retailer on that date.
